
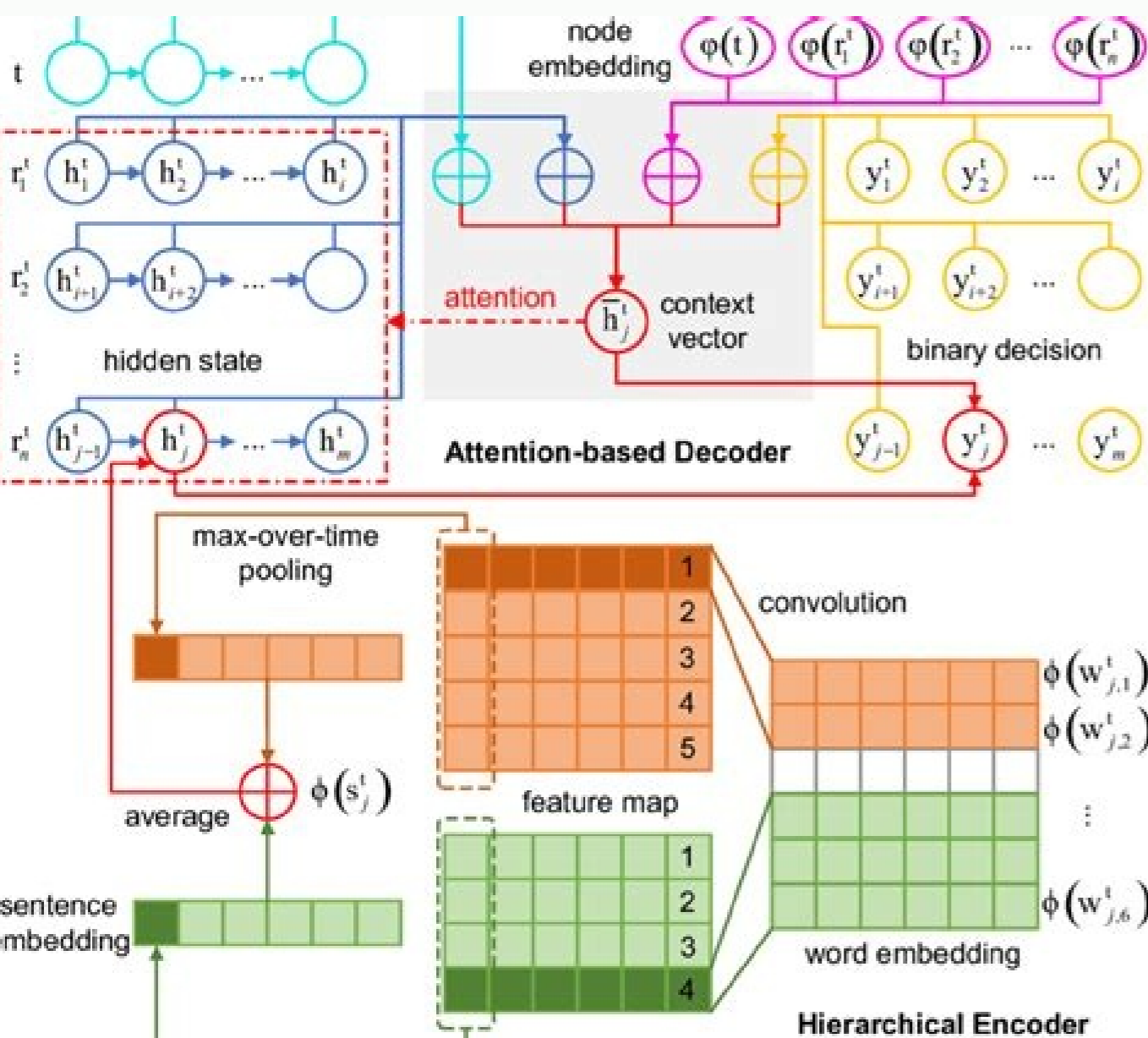
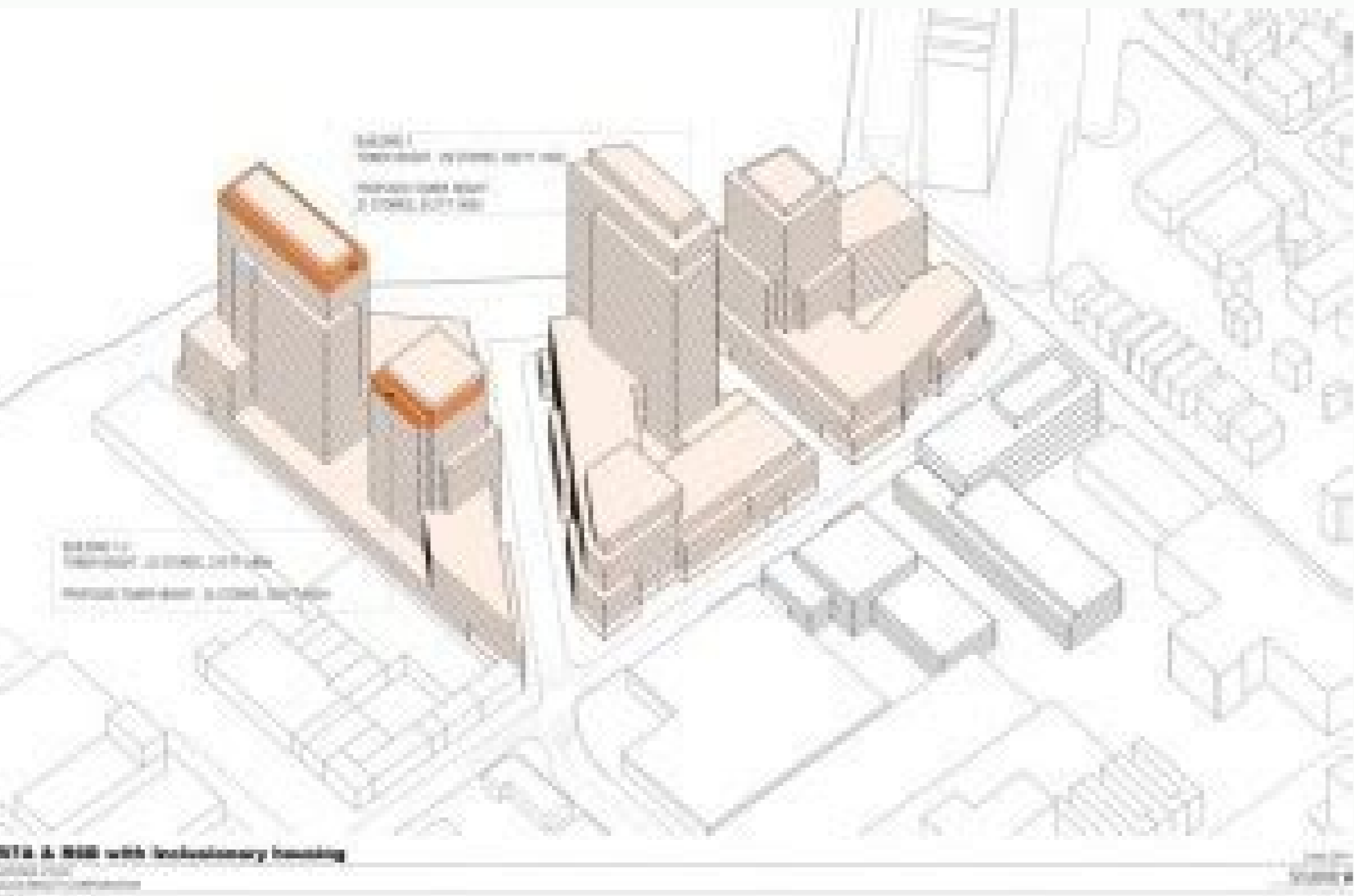

The CEQR requires city agencies to assess, disseminate and mitigate as far as possible the significant environmental consequences of their decisions to finance, undertake or approve a project. In the case of impact assessments started before the date of issue which are not considered complete as of that date, through the issuing of a negative declaration, conditional negative declaration or final environmental impact statement, the lead agency should consider whether it is appropriate to carry out an integration of the impact assessments to reflect an updated CEQR technical manual methodology, taking into account, if necessary, the expected timetable for the completion of the environmental review under the applicable approval procedure. Although the manual does not explicitly address the impact on human rights, it provides detailed guidance on how an environmental review of a project should investigate and, if necessary, plan for mitigation of a wide range of potential social, health, historical and cultural impacts. A was then revised in 2001, 2010 and for example, the chapter on public health outlines the different scenarios where a public health assessment would be required and provides detailed information to carry out this assessment. The manual (in PDF format) summarizes the CEQR procedures and provides guidelines on substantial areas of analysis usually evaluated in an environmental analysis. The manual consists of 24 chapters, including chapters dedicated to conditions to historical and cultural resources, hazardous materials, air to air Greenhouse gas emissions and climate change, public health, natural resources, noise, neighborhood character, community services and water infrastructure.
